NCSA Team Reps,

The NCSA will be hosting the 2022 First State Showdown Tournament at the Midway Softball Complex in Wilmington, Delaware on October 8th and 9th. Below is all of the information your team will need for the tournament. Please take the time to read through it and let me know if you have any questions.

This tournament will be open to 8-12 teams. Registration will occur on a first-come, first-serve basis and is now open for all of you through September 1, 2022. The **first 12 teams** that respond with their contract to the NCSA will be guaranteed a spot.

The registration fee is \$400 and you will be guaranteed a minimum of 4 games as a tournament participant. This registration fee covers fields, umpires, and game balls. Teams will be placed in two or three pools of 4 teams for pool play and all teams will proceed to an elimination round. Games will be played on Saturday and Sunday at Midway Softball Complex, which is a five-field complex. The schedule for the event will be built after all team's register. The contract for the tournament is attached to this email. After September 21st, no refunds will be given. All games will be conducted under official NCSA rules. If you have any questions about these rules please reference the NCSA website (www.clubsoftball.org).

Registration forms can be submitted via scan/email or may be mailed to the NCSA office (address listed above). Checks can be mailed to the NCSA office. Once your check and contract are received in the NCSA office, I will send each of you a confirmation email. On September 23rd or once the tournament has reached 8-16 teams (whichever comes first), I will email all participating teams with the schedule and general operating procedures of the tournament.
